

DESCRIPCIÓ / DESCRIPCIÓN

Description

These awards want to recognize and disseminate innovative and inspiring initiatives with a measurable impact on the achievement of the Sustainable Development Goals (SDG).

The prizes consist of 10 modalities grouped into 5 categories:

- Category Business Initiatives:

- Modality 1: Award for the best contribution to the SDGs made in an SME.
- Modality 2: Award for the best contribution to the SDGs made in a large company.
- Modality 3: Award for the best awareness campaign on the SDGs promoted by a company.

- Category Social Initiatives

- Modality 4: Award for the best contribution to the SDGs made in a non-profit entity or by a citizen initiative.
- Modality 5: Prize for the best awareness campaign on the SDGs promoted by a non-profit entity or a citizen initiative.

- Media Category

- Modality 6: Award for the media outlet with the best coverage of news related to the SDGs.
- Modality 7: Prize for the best journalistic report on the SDGs published in a media outlet in Barcelona.

- Category Educational Projects

- Modality 8: Award for the best contribution to the SDGs made in a primary school.
- Modality 9: Award for the best contribution to the SDGs made in a secondary school.

- Category Cities

- Modality 10: Award to the city with the best practices for achieving the SDGs.

The prizes are compatible with any other aid or subsidy granted by other administrations, public or private entities, including municipal subsidies.

Interested persons/entities

Who can apply?

The call is open to anyone:

- Natural or legal person registered or with registered office or delegation in the city of Barcelona or its metropolitan area.
- **Exceptionally, the modality 10 (Award for the city with the best practices for achieving the 2030 Agenda), is open to local authorities from all over the world with jurisdiction over an area with more than 50,000 inhabitants.**
- Groups of individuals and/or legal entities, public or private, even if they lack legal personality.

Requirements

The following requirements must be met:

- The minimum age to be a beneficiary of the prizes is 18 years old at the time of submitting the application. The calendar year in which the call is published will be used as a reference.
- The legal entities that present candidacy as such must be legally constituted.
- Applicants may apply for more than one award modality, but can only be awarded in one of them.
- Actions included in the proposal must have been carried out during the two years prior to the publication of this call. It is also possible to include actions that, although not completed, have already been put into practice and have generated some impact. It will not be possible to present actions that are still in the project phase and, therefore, have not been started.

Submission process

How is the proposal processed?

Before starting the procedure, you must download, fill in and save on your computer the standardized form that you will find in the Documentation section of this same procedure. It must be attached as part of your application documentation.

1. Fill the form.
2. Attach the normalized instance
3. Confirm the data and sign the application to submit it in the electronic registry

Presentation of applications: from April 26 **to June 14, 2022**, both inclusive.
